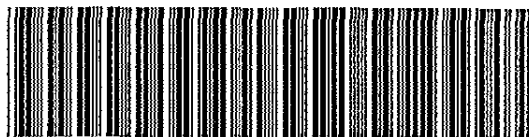

THE UNDERSIGNED, DANIEL H. BIRD, hereby executes this document for the purposes of becoming incorporated under the laws of the State of Florida, and forming a corporation under the following:

ARTICLE I

The name of this Corporation shall be: **D. H. Bird, Inc.**

ARTICLE II


