**ARTICLES OF INCORPORATION
OF

ARTICLE ONE. NAME

The name of the corporation is COUNTERTERRORISM TECHNOLOGIES CORP..

ARTICLE TWO. PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE THREE. POWERS

The corporation shall have all of the powers enumerated in the Florida General Corporation Act.

ARTICLE FOUR. CAPITAL STOCK

This corporation is authorized to issue 1,000,000 shares of Class A voting common stock which shall have par value of \$.001 per share and each share shall be entitled to one vote on all matters in which shareholders are entitled to vote.

This corporation is also authorized to issue 10,000,000 shares of Class B non-voting common stock which shall have a par value of \$.001 per share and which shall have the same rights as the Class A stock except that the Class B shares shall not be entitled to voting rights except on matters in which the right to vote may not be limited by these Articles under the provisions of Chapter 607 of the Florida Revised Statutes.

ARTICLE FIVE. PRINCIPAL OFFICE

ARTICLE NINE. AMENDMENT

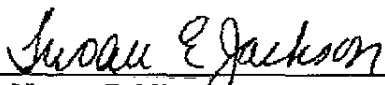

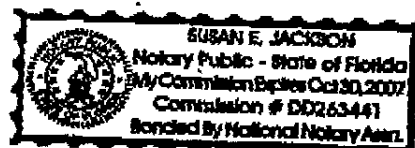
