The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I. NAME.

The name of the corporation shall be NRT Acquisitions, Inc. The initial principal place of business of this corporation shall be 4415 Metro Parkway, Suite 325, Fort Myers, Florida, 33916.

#### ARTICLE II. NATURE OF BUSINESS
