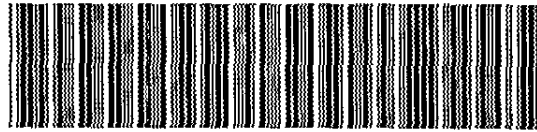

The undersigned, desiring to incorporate under the laws of the State of Florida, hereby submit the following:

**ARTICLE I**



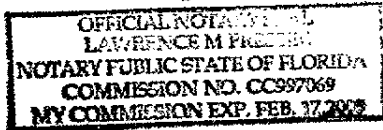

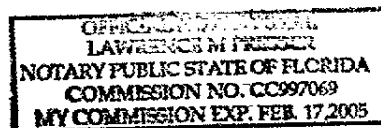
