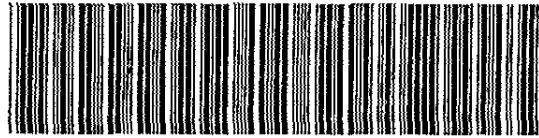

ARTICLE I. CORPORATE NAME.

The name of this corporation is : **Jerry's Communications, Inc.**

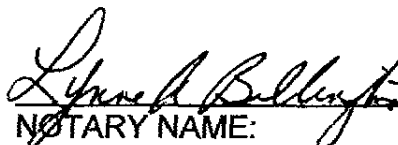
