ARTICLE I

Name: The name of this corporation is SCRIBBLES PAINTING, CORP. The Address of the corporation is 9700 SW 67th Terrace, Ocala, Florida 34476.

ARTICLE II

<u>Business and Activities</u>. This corporation may, and is organized and authorized to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

<u>Capital Stock</u>. Unless otherwise expressly prohibited by the Florida General Corporation Act, and except as otherwise provided in the foregoing sentence, the


