

In compliance with the requirements of Florida Statute Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is HEWETT PAINTING, INCORPORATED.

ARTICLE II

The existence of the Corporation shall begin on the day the Articles of Incorporation are filed with the Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 5655 Hummingbird Road, Bascom, Florida 32423. The mailing address of the Corporation is 5655 Hummingbird Road, Bascom, Florida 32423.

ARTICLE IV




