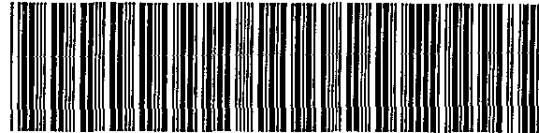

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A
CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, DO
HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE: **A-1 DECORATIVE

ARTICLE II

THE DURATION OF THE CORPORATION IS PERPETUAL.

ARTICLE III

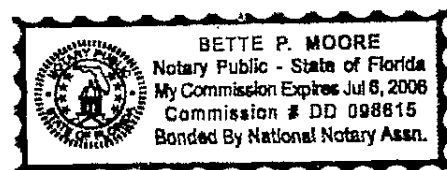


