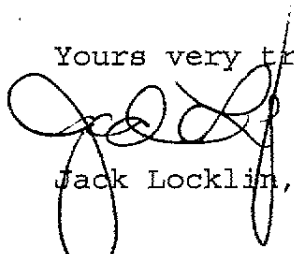

**ARTICLE I**

The name of this corporation is: **PERRITT'S CLEANING SERVICE, INC.,**

**ARTICLE II**

The term of existence of the corporation is perpetual.

**ARTICLE III**

The purpose of this corporation is to provide cleaning services for commercial and residential structures and any and all other lawful business.

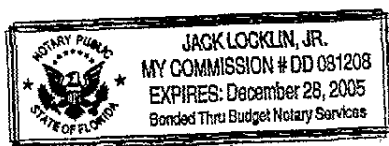

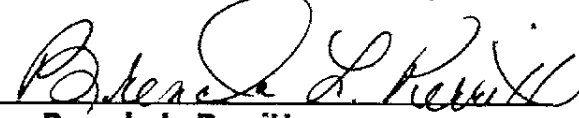

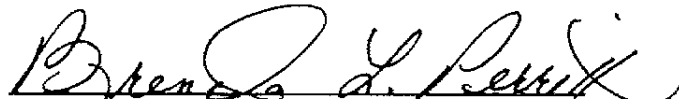
