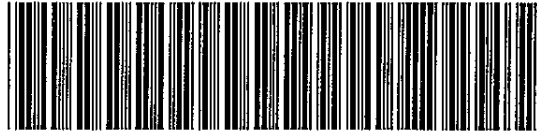

ARTICLE I - CORPORATION NAME

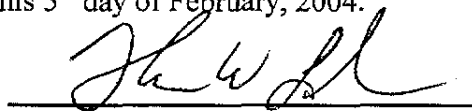
