CERTIFICATE OF INCORPORATION

OF

OCEAN JAMMER CORP.

We, the undersigned incorporator(s), hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of incorporation for profit.
