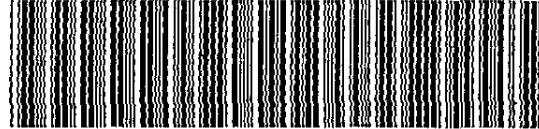

**ARTICLES OF INCORPORATION
OF
GPF MARKETING, INC.**

THE UNDERSIGNED, natural person(s) of legal age, acting as incorporator(s) of a corporation under the laws of the State of Florida, adopt the following Article of Incorporation for such Corporation.

ARTICLE I - NAME

The name of the corporation is GPF MARKETING, INC.

ARTICLE II - DURATION

The period of its duration is perpetual.

ARTICLE III - NATURE OF BUSINESS

The purpose(s) for which this corporation is organized is "To operate a Marketing Business in Goods and Services to the general public "consistent with sales and services of the industry". 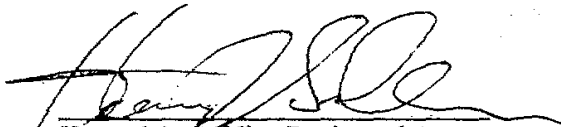
