**ARTICLES OF INCORPORATION**  
**OF**  
**CREATIVE STAFFING CONCEPTS, INCORPORATED**

The undersigned, being a natural person, does hereby act as incorporator in the adopting the following articles of incorporation for the purpose of organizing a stock corporation pursuant to the provisions of the FLORIDA stock corporation act:

FIRST: The name of the corporation (hereinafter called the corporation) is CREATIVE STAFFING CONCEPTS, INCORPORATED. The principle office is located at 419 Cypress Dr. Apt. 18-F, Tequesta, FL.

SECOND: The duration of the corporation shall be perpetual.

THIRD: The purpose for which the corporations is organized, which shall include the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the FLORIDA STOCK CORPORATION ACT, are as follows:  
To provide advice on matters of business staffing.

To have, in furtherance of the corporate purposes, all of the powers conferred upon business corporations organized under the FLORIDA STOCK CORPORATION ACT.

FOURTH: The total numbers of shares, which this corporation shall have authority to issue, is 10,000 shares of par value at \$1.00 per share. All stock of the corporation shall be of the same class, common, and shall have the same rights and preferences. Fully paid stock of this corporation shall not be liable to any further call or assessment.

FIFTH: These articles of Incorporation may be amended by the affirmative vote of a majority of the shares entitled to vote on each such amendment.

SIXTH: The corporation shall, to the fullest extent permitted by the provisions of the FLORIDA STOCK CORPORATION ACT, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any bylaw, vote of the stockholders, or disinterested directors or otherwise, both as to action in his or her official capacity and as to action while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.

2. The stated capital of the corporation may be reduced by the Board of Directors, without the assent of the stockholders.


