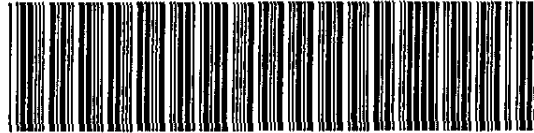

The name of this corporation is EXACT MATCH, INC. The address for the corporation is 466 Wood Street, #1, Dunedin, FL 34698.

ARTICLE II - DURATION

This corporation shall exist for a perpetual period.

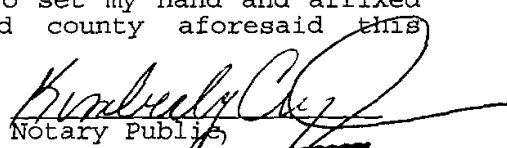

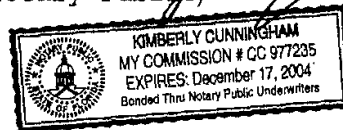
