The undersigned, for the purpose of forming a Corporation under Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND PLACE OF BUSINESS

The name of this Corporation is Beautiful Walls, Inc. with its principal place of business at 210 Cypress Road, St. Augustine, Florida 32086.

ARTICLE II

DURATION

This Corporation shall exist perpetually.
