ARTICLES OF INCORPORATION

FOR

The undersigned hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges, and minimities of a corporation for profit.

ARTICLE I

The name of this corporation shall be

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all things mentioned heroin as fully and to the same extent as a natural person might or could, vis:

- To engage in every aspect and phase of husiness under the laws of the United States of America
- To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in, and with, goods, wares, merchandise, real and personal property, and services of every class, kind, and description; except that it is not to conduct a banking safe deposit, trust, insurance, surety, express, rail-road, canal, telegraph, telephone or conjuctory company, a building and loan association, mutual fire insurance association, cooperative association, finternal benefit society, state fair or exposition.
