ARTICLE I

The name of this corporation is: **EXPRESSIONS, INC.,**

ARTICLE II

The term of existence of the corporation is perpetual.

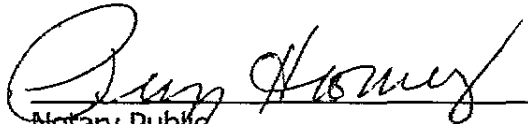
