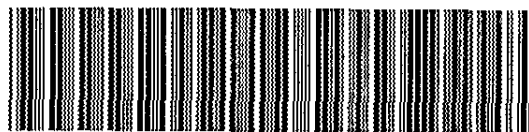

# ARTICLES OF INCORPORATION FILED

The undersigned incorporator, being a natural person competent to contract for the purpose of forming a Professional Association Corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation in order to form a Professional Association Corporation under the laws of the State of Florida.

## ARTICLE I

The Professional Association Corporate name is: **Robert A. Combes, P. A.**

## ARTICLE II

The initial street address and mailing address of the principal place of the Corporation is:

## ARTICLE III

This Corporation shall commence upon the filing of these Articles and shall exist perpetually.

## ARTICLE IV

This Professional Association Corporation is formed for the specific purpose of providing licensed real estate services.

## ARTICLE V

This Corporation is authorized to issue 10,000 shares of \$ 1.00 par value, common stock. The rights attendant to all such shares, once issued, shall be identical in all respects. The shares of this Corporation are not to be divided into classes. This Corporation is not authorized to issue shares in series or in less than whole shares.

Every Shareholder, upon the issuance of any new stock of this Corporation, shall have the right to purchase his or her pro-rata share thereof (as nearly as can be done without issuing fractional shares), at the price at which it is offered to others.

## ARTICLE VII

## ARTICLE X

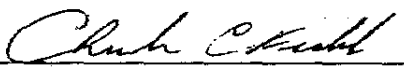
