ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is SURFACE SPECIALISTS SUN EAST, INC. The address for the corporation is $6049\ 112^{th}$ Avenue, Pinellas Park, FL 33782.

ARTICLE II - DURATION

This corporation shall exist for a perpetual period.

ARTICLE III - PURPOSE
