ARTICLE VIII - Amendment

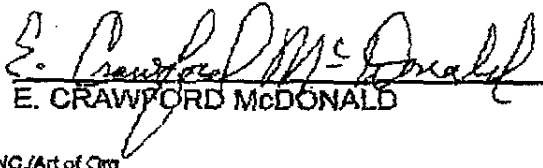
