

ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS:

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried On are: EXPORT AND IMPORT, FOODS, CAN GOODS, ANYTHING RELATED TO THE FOOD INDUSTRY, MISCELLANEOUS...

And, in general, to carry on any business whatsoever in connection with the foregoing or which Is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value Of its properties.
