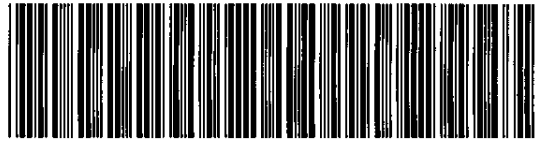

FOURTH: The amendment was adopted by the President on the 11 day of **December, 2006**.

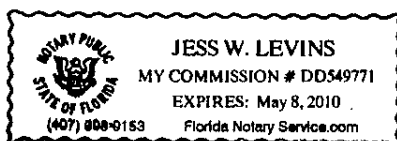
