ARTICLES OF INCORPORATION  
OF

Article I

Name. The name of this Corporation is Angel Food Ministry, Inc., and the principal office address of the corporation is 7680 Silver Sands Road, Keystone Heights, FL 32656.

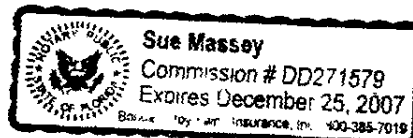
