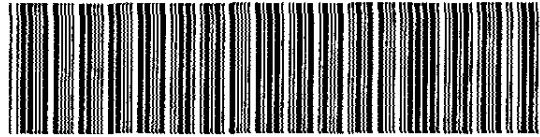

The undersigned incorporation, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation. SECRETARY OF STATE
TALLAHASSEE, FLORIDA

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be VIKING HOLDINGS OF PASCO COUNTY, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

ARTICLE IX - INITIAL BOARD OF DIRECTORS


