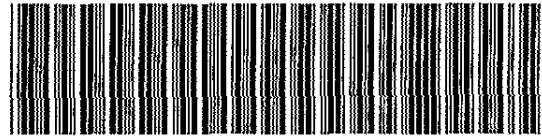

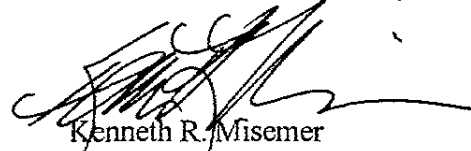

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida general corporations act, adopts the following Articles of Incorporation for that corporation.

1. NAME: The name of this corporation is THE ALLGOOD CAMP, INC.

2. DURATION: The period of its duration is perpetual.

3. PURPOSE: The purpose is to be the tenant and assignee of a submerged lands lease from the State of Florida Board of Trustees (BOT Campsite Lease No. 2426) and to engage in any related activities or business permitted under the laws of the United States and Florida.

4. CAPITAL STOCK: The corporation is authorized to issue 1000 shares, all of one class, at \$1.00 par value.

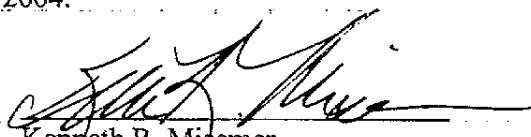

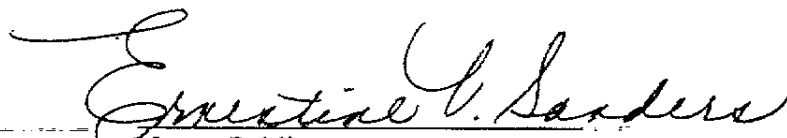

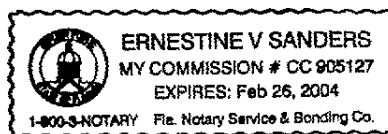
