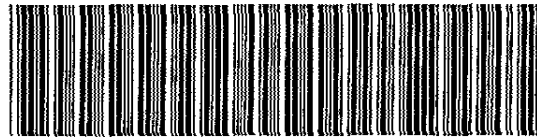

ARTICLE I – NAME

The name of this corporation is WINGS EDUCATIONAL HUMAN RESOURCES, INC.
The address of said Corporation is 6038 Indrio Road, S-2, Fort Pierce, Florida 34951.

ARTICLE II – CORPORATION PURPOSE

The general purpose of this corporation shall be to provide children with the necessary resources to gain a firm foundation in academic concepts. The Corporation through the use of audio and visual productions will target fundamental skills required for children to obtain optimal success. The Corporation shall utilize any and all lawful means to achieve its objectives and it shall engage in any and all lawful business in the United States of America.

ARTICLE III- DURATION

The Corporation shall have perpetual existence.

ARTICLE IV – STOCKS

The maximum number of shares which this Corporation is authorized to have outstanding at anytime is 1,000 shares of common stock having a par value of \$1.00 per share..
