

ARTICLES OF INCORPORATION

The undersigned incorporators make, subscribe, acknowledge, and file with the Department of State of the State of Florida the Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I : NAME

The name of this Corporation is **The Welder Guy, Inc.**, with a principal office and mailing address of 532 Underhill Drive, Orlando, Florida 32803.

ARTICLE II : TERMS OF EXISTENCE

This Corporation shall commence as of the date of the completed execution, acknowledgment, and filing date by the Secretary of State of Florida of these Articles and shall have perpetual existence.

ARTICLE III : NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV : CAPITAL STRUCTURE

The total number of shares of capital stock authorized to be issued by the Corporation will be one hundred (100) shares of common stock of the same class, having a par value of no par per share. Each of the said shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders.

ARTICLE V : INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this Corporation is 532 Underhill Drive, Orlando, Florida 32803; and the name of the initial registered agent of this Corporation at that address is Paul K. Smith. The Board of Directors may, from time to time, move the principal office to any other address.

ARTICLE VI : BOARD OF DIRECTORS

There shall be a Board of Directors for this Corporation which shall consist of not less than one (1). Except for the number constituting the initial Board of Directors, the number of directors may be increased or diminished from time to time by the By-Laws adopted by the Shareholders.

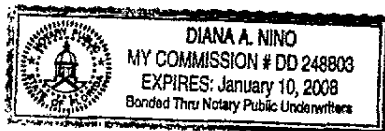
