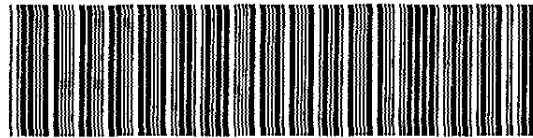

The name and address of the individual who is to serve as the initial director is Timothy Pingle, 3617 Waverly Court, Destin, FL 32541


