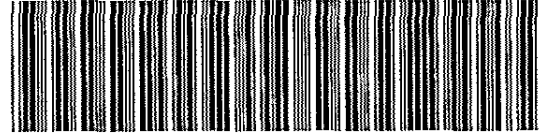

OF THE PERSON AND PROPERTY**


TO ALL WHOM IT MAY CONCERN:
