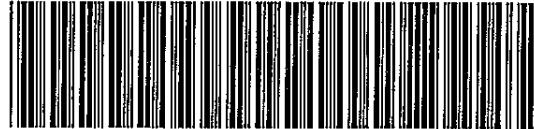



ARTICLES OF INCORPORATION OF
CRX-USA, INC.

ARTICLE I – NAME

The name of this corporation is CRX-USA, INC.

ARTICLE II – DURATION

This corporation shall exist perpetually, beginning in accordance with law.


ARTICLE VII - BY LAWS

ARTICLE IX - AMENDMENT

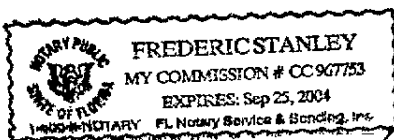


