

ARTICLES OF INCORPORATION OF Code Carpentry, Inc.

The undersigned, for the purpose of forming a for profit corporation under Florida Statutes Chapter 607, does hereby make and adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of this Corporation is Code Carpentry, Inc.

ARTICLE II. ADDRESS OF CORPORATION

The address of the principle office is 661 19th Street SW, Naples, Florida 34117. The mailing address of the principle office is the same.

ARTICLE III. PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business are as follows:

- 1. To engage in the service of Carpentry (Framing) as a service corporation and to provide services incident thereto.
- 2. To own property, enter into contracts and carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of the Corporation.
- 3. The services of this Corporation, which consist of Carpentry (Framing), shall be carried out only through officers, employees and agents.
- 4. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida, or by the provisions of these Articles of Incorporation.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 500 shares having a par value of \$1.00 per share. Such shares shall be of a single class of common stock.

ARTICLE V. DURATION

The Corporation shall have perpetual existence.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the principal and initial registered office of the Corporation is 661 19th Street SW, Naples, Florida 34117, and the name of the initial registered agent is Damian Gonzalez. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

ARTICLE VII. BOARD OF DIRECTORS

The Corporation shall be managed by a Board of Directors of at least one (1) Director. The Directors shall be elected by the shareholders of the Corporation. The name and street address of each person who is to serve as a member of the initial Board of Directors is as follows:

ARTICLE XI. AMENDMENT

These Articles of Incorporation may be amended by the Board of Directors from time to time in the manner provided by law.
