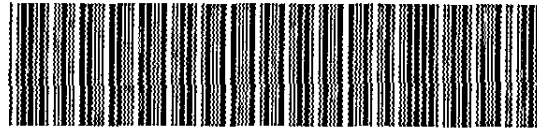

ARTICLES OF INCORPORATION

OF

WW TILE SERVICES, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be WW TILE SERVICES, INC.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on January 30th, 2004 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

The mailing address of the corporation is 16123 N.W. 45 Avenue, Miami, FL 33054.

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

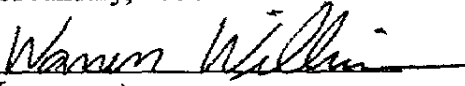
ARTICLE VIII - SHAREHOLDER PROPERTY

The shareholders shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
