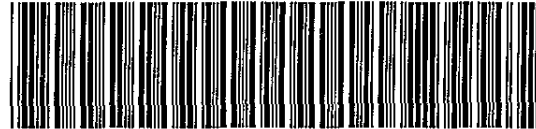



The number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares having a par value of one (\$1.00) per share.


ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.
