The undersigned subscriber to these Articles of
Incorporation, being a natural person competent to contract,
hereby forms a corporation under the laws of the State of
Florida.

# ARTICLE I

#### Name

The name of the corporation shall be DeLAND TAXI, INC.

## ARTICLE II

#### Existence

This corporation shall have perpetual existence.

#### ARTICLE III

## Nature of Business

The general nature of the business to be transacted by this corporation shall be the powers inherent mentioned in Section 607.011 of the Florida Statutes, and in addition thereto, it shall have the following powers:

- (a) To engage in any activity or business permitted under the laws of the United States and of this state, including but not limited to, transportation of people.
- (b) To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise dispose of and deal in, lands, leaseholds,

indebtedness created by any other corporation of the State of Florida, or any other state or government, and while owner of such stock, to exercise all rights, powers and privileges of ownership, including the right to vote such stock.

- (h) To exercise all the powers now granted to this type of corporation under Florida law and all powers subsequently authorized or granted by law to private corporations, and in general to carry on any lawful business necessary or incidental to the attainment of the objectives enumerated in these Articles of Incorporation, or any amendments thereof, or necessary or incidental to the protection or benefit of this corporation.
- (i) The foregoing clauses shall be construed both as objects and powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation, and this corporation shall have the right to engage in and carry on any business not specifically prohibited corporations of this class and character by the laws of the State of Florida.

#### ARTICLE IV

## Capital Stock

The maximum number of shares of capital stock that this corporation is authorized to have outstanding at any one time is 200 shares of common stock, having no par value per share. Each share of stock shall be entitled to one vote, non-cumulative, and shall be subject to such restrictions of transfer thereof as may be hereafter adopted by the shareholders and included in the By-Laws of this corporation.

## ARTICLE V

## Initial Capital

The amount of capital with which this corporation shall begin business shall not be less than Five Hundred Dollars (\$500.00).

#### ARTICLE VI

# Location of Business Office, Registered Office and Registered Agent

The business office of this corporation shall be located at 502 South Adelle Avenue, DeLand, Florida 32720, and its mailing address shall be the same. The registered office of this corporation shall be located at 108 West Rich Avenue, DeLand, Florida 32720, and the Registered Agent of the corporation shall be Robert R. Foster.

# Amendments to Articles

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board
