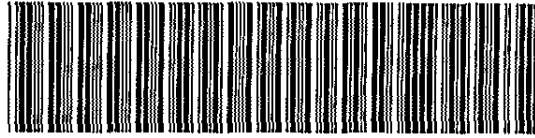




ARTICLE VIII


