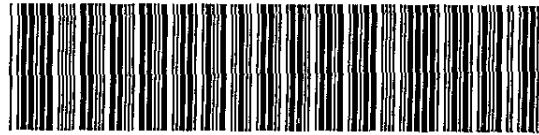

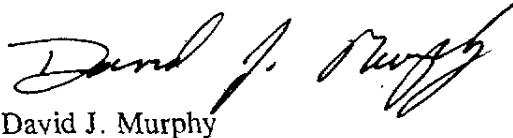

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I - NAME

The name of this corporation is KD OF PASCO, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - CAPITAL STOCK

The capital stock of this corporation shall consist of and the corporation is authorized to issue one thousand (1,000) shares of voting Class "A" common stock which shall have a par value of One Dollar (\$1.00) per share and one thousand (1,000) shares of non-voting Class "B" common stock which shall have a par value of One Dollar (\$1.00) per share.

Such common stock shall be issued as "small business corporation" stock in accordance with a plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1954.
