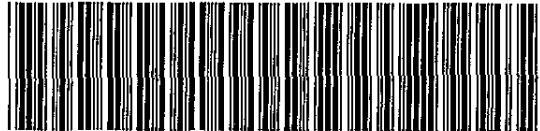

**ARTICLES OF INCORPORATION
OF
RAINFOREST CARPENTRY, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following articles of incorporation:

ARTICLE I

The name of this Corporation is: RAINFOREST CARPENTRY, INC.

ARTICLE II

NATURE OF BUSINESS: The general nature of the business to be transacted by this corporation is:
