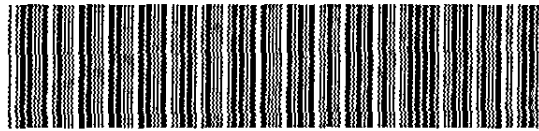

**ARTICLE I**

The name of this corporation is: **DZD SERVICES, INC.,**

**ARTICLE II**

The term of existence of the corporation is perpetual.

**ARTICLE III**


