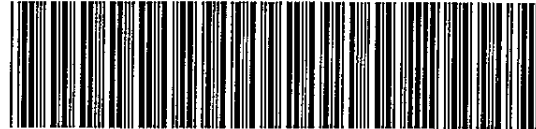

ARTICLES OF INCORPORATION
OF

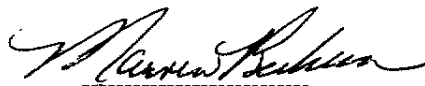
