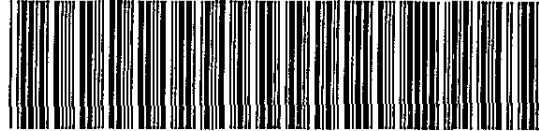



ARTICLES OF INCORPORATION
OF

ARTICLE I- NAME

The name of the Corporation shall be TRISTAR TRUCKING AND MATERIAL, INC.

ARTICLE X- AMENDMENTS TO ARTICLES OF BY-LAWS

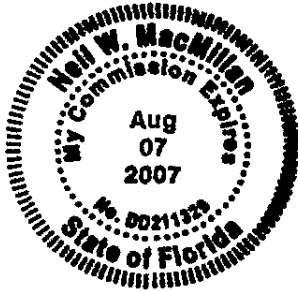
The Power to adopt, amend, alter, or repeal these Articles of corporation as well as the By-Laws of this corporation shall be reserved to the shareholders.
