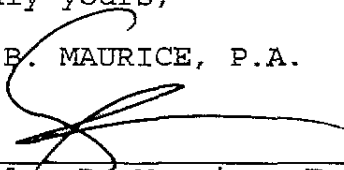

ARTICLES OF INCORPORATION
for
KMS TOOLS, INC.

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. Name: The name of the corporation is KMS TOOLS, INC. The address of the corporate office shall be 2624 Crabapple Circle, Boynton Beach, Florida 33436.

ARTICLE II. Duration: The period of this corporation's duration is perpetual.

ARTICLE III. Purpose: The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida, including the sale of tools, buying, selling of tools and accessories and related activities, within and without the State of Florida.
