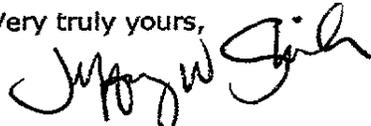

ARTICLES OF INCORPORATION

TRUE LIES YOUTH TALKS, INC.

ARTICLE I. CORPORATION NAME

The name of the corporation is:

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in the business of school/church educational seminars and any and all business as permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

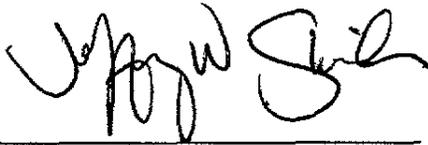

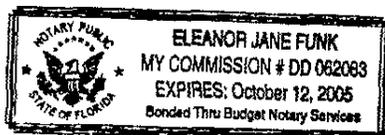

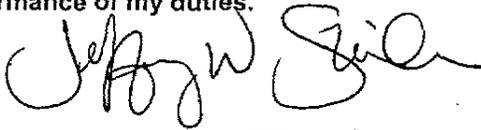
