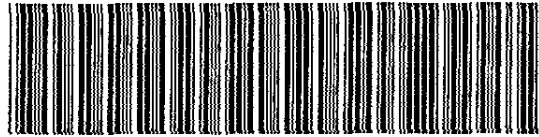

THE UNDERSIGNED, acting as sole incorporator of OUTBOARD MOTORS ONLY, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be OUTBOARD MOTORS ONLY, INC.

ARTICLE II

Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

ARTICLE III

Principal Office

The address of the Principal Office of the corporation is 19829 County Road 455, Ferndale, FL 34729. The location of the Principal Office shall be subject to change as may be provided for in the bylaws duly adopted by the corporation.

ARTICLE IV

Initial Registered Office and Agent

Initial Board of Directors

The number of Directors constituting the initial Board of Directors of the corporation is one. The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than two (2). The persons who are to serve as initial Directors until the first annual meeting of the shareholders of the corporation or until such successor Directors are elected and shall qualify is Bruce P. Sebastian.

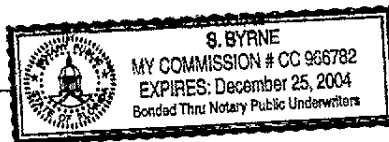
