

ARTICLE I. NAME

The name of this corporation is  
JEFFRIES & CAMPBELL CONSTRUCTION CO.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE



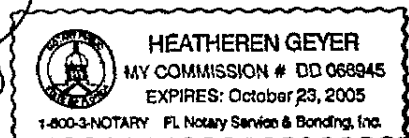


