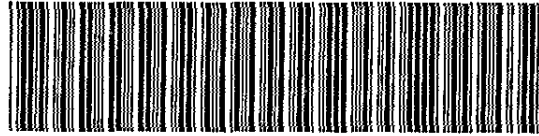



**Article I – Name**

The name of this corporation is: THOMAS BAYER STUCCO, INC.

**Article II – Duration**

This corporation shall have perpetual existence.

**Article III – Purpose**

The purpose of this corporation shall be to provide stucco and related exterior finish services and any lawful business not prohibited by the laws of the State of Florida or the United States of America.

**Article IV - Capital Stock**
