The undersigned subscribers to these Articles of Incorporation each a natural person competent to contract, hereby associate themselves to form a corporation under the laws of the State of Florida.

ARTICLE ONE

The name of the corporation is

The general nature of the business to be transacted by the Corporation is:

- a. The practice of medicine and operation of medical and professional offices.
- b. Any activity or business permitted under the laws of the United States and/or the State of Florida.
