ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Advenir Construction, Inc. Its principal office address and business mailing address is 4780 NW 9th Street, Plantation, Florida 33317.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK
