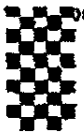

**FIRST:** Article I of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:


**Article I
