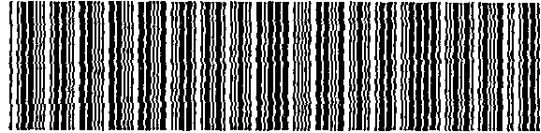

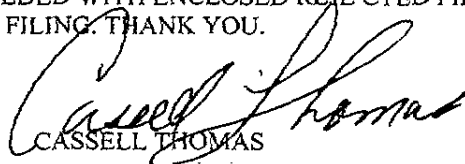

ARTICLE I

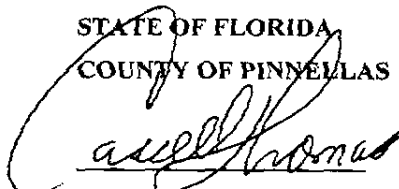
ARTICLE XI

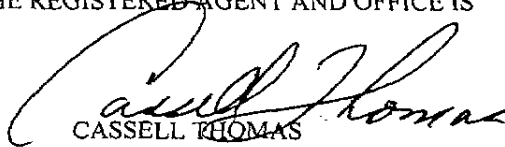

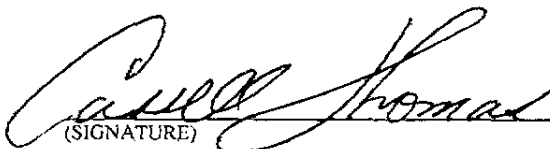
