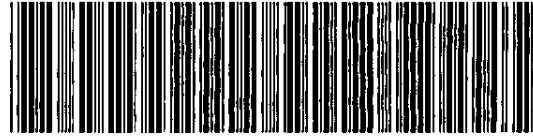




FINGERSHIELD RESIGANTION
